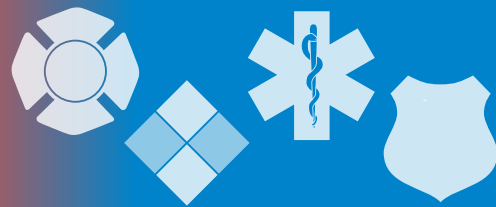

## Long-term health effects of major hurricanes

Hurricanes can have long-lasting effects that go far beyond loss of life, physical damage and property loss. After the storm, affected communities may deal with challenging physical, mental, emotional and environmental consequences. Emergency managers, first responders and public health professionals should know about these issues and be able to direct people to available resources.

The Centers for Disease Control and Prevention (CDC) covers these topics, tailoring information to leaders, emergency responders, and state and local governments. Each has a different role in disaster planning and response, and therefore can help communities recover in different ways.

The CDC joins with the [Substance Abuse and Mental Health Services Administration \(SAMHSA\)](#) in an upcoming webinar to teach community leaders, public health professionals, health educators and other stakeholders about health issues and mental health concerns that may linger after a hurricane.

## Resources for a cyber-safe Emergency Services Sector workforce

Cyber attackers regularly target state, local, tribal and territorial (SLTT) governments and it's vital everyone knows their role in keeping networks secure. Decisions affecting network security often fall to those in leadership roles even though you may have little experience with the cybersecurity.

Identifying quality cybersecurity training for staff or hiring for cyber-related positions can be challenging. Here are a few resources to assist you with these endeavors:

## Scholarships for fire, emergency medicine and hazmat training

The Yvorra Leadership Development (YLD) Foundation is accepting applications for 2018 scholarships and awards through the end of October. These awards focus on improving leadership development, education and skill building in fire, emergency medical and hazardous materials emergency response.

The foundation is named after Deputy Chief James G. Yvorra of the Berwyn Heights Fire Department in Prince George's County, Maryland. Deputy Chief Yvorra lost his life while responding to an accident in 1988. He was a leader in first responder training and was an author of training textbooks and programs.

The YLD Foundations was established soon after his death and has awarded more than \$163,000 to 99 individuals and organizations pursuing training and education for first responders since then.
