

National Fire Academy Criteria for Contract Instructor Selection

Course: Plans Review for Fire and Life Safety (R0393)

Curriculum: Fire Prevention: Technical

This six-day course will assist the student in verifying that construction documents comply with applicable building and fire codes for fire protection and life safety requirements.

Subjects addressed in the course include site plan reviews for emergency apparatus access, water supply, and hydrants for fire protection; and review of architectural drawings for construction requirements, means of egress for life safety, and fire-resistive compartmentalization.

Criteria for Contract Instructor Selection

All new contract instructors shall be evaluated in three consecutive course deliveries in accordance with the National Fire Academy's (NFA's) Contract Instructor Evaluation program. Existing contract instructors are subject to evaluation in accordance with this program.

1. Academic Requirement

a. Minimum:

- Associate degree from an institution that is accredited in fire protection technology, fire administration, fire science, or a similar program.
- Candidates are encouraged to have successfully completed this course in the last three years and/or serve as an adjunct instructor (in training) in this course.

b. Preferred:

A bachelor's degree from an institution that is accredited in fire protection technology, fire administration, fire science, or a similar program.

2. Documented Knowledge and Experience

a. Accepted formal instructional training, such as:

- state fire training certificate;
- college teacher's credential;
- college education courses; or
- thirty-two hours of documented, successful fire/emergency services instruction.

- b. The candidate should be experienced, proficient and knowledgeable of current issues in the field of expertise for the content of this course.
- c. The candidate should have the necessary experience to be capable of presenting all units of the course. It is recognized that exceptions may occur where courses are of such a technical nature that no one person may be technically competent to instruct all units.
- d. Current knowledge of general fire safety conditions, occupancy classifications and hazards, occupant life safety, building exiting systems, electrical heating, and cooking equipment and system hazards.
- e. Current knowledge of automatic sprinkler systems, special hazard fire suppression systems, water supply requirements for fire suppression systems, standpipe systems, fire alarm/detection systems, and portable fire extinguishers.
- f. Current knowledge of the behavior of fire and its effects on building materials and systems, human behavior in fire situations, fire heat and smoke spread and travel in a structure, building construction classifications, and principles of controlling fire hazards associated with hazardous materials.

3. Continuing Practice or Education

Ability to maintain currency in the field and the specific course by:

- a. teaching a similar course at a training academy, college or university;
- b. taking a similar course within the last five years;
- c. developing a similar course within the last five years;
- d. teaching the course at the NFA or in the field within the last two years;
- e. writing and researching a paper or article related to the course topic for at least one of the fire service or related disciplines' trade journals within the last two years; or
- f. attending and/or speaking at a conference related to the field at the local, state, tribal or national level within the last three years.

Failure to provide approved documentation of ongoing training or instruction may result in revocation of the contract instructor status.

4. How to Submit an Application

The following documents are required with each submission:

- a. A cover letter listing the courses you want to teach.
- b. Your résumé.
- c. Documentation that clearly addresses how you meet the instructor selection criteria for each course you are seeking to teach (e.g., academic requirement, instructional experience, knowledge and experience in the subject matter, and continuing practice or education). This document needs to be written in that order. Incomplete packages will not be processed.

- d. Three references from persons who are knowledgeable about your character, as well as your teaching ability. One reference letter should be from the department or agency head in your organization or certifying organization.
- e. Include a current email address so we can communicate more efficiently with you.
